Overall Supervisor Prill was happy with the response. Commissioner Herrmann asked given the circumstances will any athletic programs be able to run either a shortened season or spring camp. Supervisor Prill is continuing to brainstorm and hopes to offer something once the Stay at Home order is

lifted. Northwest Little League cancelled the season- Commissioner Majcher asked if this is something the Park District could capitalize on. President Looman asked about the shortened soccer season as well as possibly extending fall soccer. Commissioner Herrmann inquired about summer camp- if all is lost or could summer camp probably run?

#### **New Business**

**A. FY21 Draft Operating Budget-** Executive Director Schraw presented the proposed budget and projections given the uncertain nature due to Covid-19. Executive Director Schraw clarified with the Board of Commissioners fund balances ending FY21 will still all be 30% in all funds. Schraw also spoke with the Boards financial advisor in regards to government entities as well as re-financing our current debt payment. In addition, the Board will be authorizing the Executive Director and HR director to make May1 payroll out of the FY20 budget due to Covid-19.

Commissioner Herrmann made a motion to approve the FY 21 Draft Operating Budget. Seconded by Commissioner Reid. Motion passed 5 Ayes, 0 Nays, 0 Abstain.

Commissioner Majcher made a motion to publish the draft appropriation ordinance and publish to the newspaper for the public hearing. Seconded by Commissioner Tiffany. Motion passed 5 Ayes, 0 Nays, 0 Abstain.

Due to the current needs with Covid-19 the Board of Commissioners give the Executive Director and HR director to make May 1 payroll out of FY 20 budget. Seconded by Commissioner Herrmann. Motion passed 5 Ayes, 0 Nays, 0 Abstain.
