

Hampshire Township Park District Board of Commissioners Meeting Minutes May 24, 2021

Call to Order:

At 6:31 p.m. President Looman called the meeting to order.

Commissioner Herrmann made a motion to approve the agenda with an added executive session. Seconded by Commissioner Tiffany. Motion passed 5 Ayes, 0 Nays, 0 Abstain.

President Looman administered the oath of office to Commissioners Majcher and Tiffany for 6 year terms.

Citizens to be Heard: Heather Fodor presented to the Board of Commissioners in appreciation and support of the dog park and filled out an application to name the dog park.

Commissioner and Staff Comments: Commissioner Tiffany asked Athletics Supervisor Prill about working together for a younger lacrosse program. Supervisor Prill said he would be more than happy to see if there is any interest and would like to work with the established lacrosse program. There continues to be interest in the British Soccer Camp.

A. Annual Meeting- At today's meeting the Board of Commissioners elected officers at their annual meeting for one year terms.

Vice President: Commissioner Reid nominated Looman for Vice President. Herrmann Seconded. All Ayes.

Secretary: Commissioner Looman nominated Commissioner Reid for Secretary. All Ayes. **Treasurer**: Commissioner Majcher nominated Commissioner Tiffany for Treasurer. All Ayes.

Commissioner Reid made a motion to elect the following officers. Seconded by Commissioner Majcher. Motion passed 5 Ayes, 0 Nays, 0 Abstain.

- B. FY22 Final Budget- Executive Director Schraw presented the final budget for Commissioner review.
- **C. Park Naming-** Executive Director Schraw presented the Board of Commissioners applications per the Park District Park Naming Policy for review. The Board of Commissioners reviewed the applications for the Park at Tuscany Woods as well as the Dog Park. Commissioner Looman asked if there would be a motion to accept the application to name the Park at Tuscany Woods Fred Rackow Park. Motion carried by Commissioner Herrman. Seconded by Commissioner Majcher. Motion passed 4 Ayes, 0 Nays, 1 Abstain.

The Board reviewed the application by Heather Fodor to name the Dog Park T.K. Getzelman Dog Park. Motion carried by Commissioner Tiffany. Seconded by Commissioner Herrman. Motion passed 5 Ayes, 0 Nays, 0 Abstain.

D. Howitzer Resolution #2021-03- Commissioner Reid made a motion to approve the Howizter Resolution #2021-03 to apply to the U.S. Army to retain and maintain the existing M114 Series Howizter at Seyller Park. Seconded by Commissioner Herrmann. Motion passed 5 Ayes, Nays, 0 Abstain.

Old Business

Tuscany Woods Construction Update-Executive Director Schraw updated the Board of Commissioners on the progress toward park completion.

Executive Director Schraw updated the Board on the status of the Splash Pad, the 'brain' of the Splash Pad was not working and it should be repaired and returned by Friday for the opening.
