Although we have already begun small celebrations at the Chamber's Ice Sculpture and Cocoa event, our St. Patrick's Day 5K and our annual egg hunt, we are gearing up for our biggest celebration yet and we want YOU to be a part of it!

After the referendum passed in 1948, the Village of Hampshire deeded East Park, now known as Ralph Seyller Memorial Park, to the newly founded Hampshire Township Park District. Since then we have expanded to four parks which include Seyller Park, Ream Park, Schmidt Park and Rackow Park totaling over 70 acres of recreational space. If you haven't heard the exciting news - Seyller Park just received an Illinois Department of Natural Resources Open Space Land Acquisition and Development Grant for a \$1.2 Million dollar upgrade! We can't wait to improve this historic property and enhance our offerings to the community.
