HAMPSHIRE TOWNSHIP PARK DISTRICT AN ORDINANCE LEVYING AND ASSESSING TAXES OF THE HAMPSHIRE TOWNSHIP PARK DISTRICT FOR THE FISCAL YEAR BEGINNING MAY 1, 2023 AND ENDING APRIL 30, 2024

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE HAMPSHIRE TOWNSHIP PARK DISTRICT, COUNTY OF KANE, AND STATE OF ILLINOIS:

SECTION1: That for the fiscal year beginning May 1, A.D. 2023 and ending April 30, A.D. 2024 the sum of Eight Hundred Four Thousand Nine Hundred Sixty-Seven and 33/100 dollars (\$804,967.33) be, and the same is hereby levied and assessed on all property subject to taxation within the Hampshire Township Park District, according to the value of said property as the same is assessed and equalized by the Department of Local Government Affairs of the State of Illinois; that the objects and the sum amount levied and assessed for each purpose respectfully, subject to the deductions specified, are as herein after in this section set forth.

I. General Corporate Fund

That there is hereby levied and assessed for the fiscal year beginning May 1, A.D. 2023 and ending April 30, A.D. 2024 the sum of Three Hundred Ninety-Four Thousand Six Hundred Fifty-Four and 80/100 dollars (\$394,654.80) upon all property subject to taxation within the Hampshire Township Park District, according to the value of said property as the same is assessed and equalized by the Department of Local Government Affairs of the State of Illinois, to defray the necessary expenses of the Park District for the general corporate purposes pursuant to Section 5-1 of "The Park District Code" as follows:

II. Recreation Fund

That there is hereby levied and assessed for the fiscal year beginning May 1, A.D. 2023, and ending April 30, A.D. 2024 the sum of One Hundred Thirteen Thousand Thirty and 92/100 dollars (\$113,030.92) upon all property subject to taxation within the Hampshire Township Park District, according to the value of said property as the same is assessed and equalized by the Department of Local Government Affairs of the State of Illinois, to pay the necessary cost to operate, administer and maintain the recreation program of the Park District pursusant ot Section 5-2 of "The Park District Code" as follows:

III. Liability Fund

That there is hereby levied and assessed for the fiscal year beginning May 1, A.D. 2023, and ending April 30, A.D. 2024, the sum of Sixty Four Thousand Eight Hundred Fifty-Seven and 33/100 dollars (\$64,857.33) upon all property subject to taxation within the Hampshire Township Park District, according to the value of said property as the same is assessed and equalized by the Department of Local Government Affairs of the State of Illinois, to pay the cost of insurance to protect against claims of public liability, workers compensation and occupational diseases, as provided by the "Local Government Employees Tort Immunity Act", as amended and as follows:

Miscellaneous	\$ 13,000.00

IV. Bond Fund

That there is hereby levied and assessed for the fiscal year beginning May 1, A.D. 2023, and ending April 30, A.D. 2024, the sum of Thirty-Seven Thousand Three Hundred Forty-Nine and 99/100 dollars (\$37,349.99) upon all property subject to taxation within the Hampshire Township Park District, according to the value of said property as the same is assessed and equalized by the Department of Local Government Affairs of the State of Illinois to pay the interest and principal of outstanding General Bonds of the Park District under the statutory enactment entitled "The Park District Code", as follows:

V. Special Recreation Fund

That there is hereby levied and assessed for the fiscal year beginning May 1, A.D. 2023 and ending April 30, A.D. 2024, the sum of One Hundred Ninety-Five Thousand Seventy-Four and 29/100 dollars (\$195,074.29) upon all property subject to taxation within the Hampshire Township Park District, to the value of said property as the same is assessed and equalized by the Department of Local Government Affairs of the State of Illinois, to defray the expenses of the Park District to provide recreational programs for the handicapped under Section 5-8 to "The Park District Code" as follows:

SECTION 2: That the total amount of Eight Hundred Four Thousand Nine Hundred Sixty-Seven and 33/100 dollars (\$804,967.33) ascertained as aforesaid, be and the same is hereby levied and assessed on all property subject to taxation within the Hampshire Township Park District according to the value of said property as the same is assessed and equalized for the State and County purposes for the current year.

SECTION 3: That there is hereby certified to the County Clerk of Kane County, Illinois, the several sums aforesaid constituting Eight Hundred Four Thousand Nine Hundred Sixty-Seven and 33/100 dollars (\$804,967.33) which said total amount the said Hamphire Township Park District requires to be raised by taxation for the current fiscal year of said Park District, and the Secretary of said District is hereby ordered and directed to file with the County Clerk of said County on or before the time required by law, a certified copy of this Ordinance.

SECTION 4: That the County Clerk of Kane County, State of Illinois, be and is hereby directed as provided by law to ascertain the rate percent which, upon the total valuation of all property subject to taxation within the Hampshire Township Park District as the same is assessed and equalized for State or County purposes, will produce a net amount as herein legally levied and to extend such tax pursuant to the statue.

SECTION 5: If any item or portion hereof of this Ordinance is for any reason held invalid such decision shall not affect the validity of the remaining portion of such item or the remaining portion of this Ordinance.

SECTION 6: This Ordinance shall take effect and be in full force and effect immediately on and after its passage and approval, as provided by law.
